VOLUNTEER RELEASE

THIS IS A LEGAL CONTRACT THAT AFFECTS YOUR RIGHTS

READ CAREFULLY

By my signature below, I, the undersigned, in consideration of being permitted to participate as a volunteer for the

Rider Relief Fund (“RRF”) at _____ (“Organization”)

and otherwise being permitted to be present in areas associated with the Event which are restricted to the general public (“Restricted Areas”), hereby represent, warrant and agree as follows:

I acknowledge that my statements in this Agreement are being accepted by RRF in consideration for and are being relied upon by RRF and/or Organization in allowing me to participate as a volunteer and/or in other activities at the Event and in permitting me to be present in Restricted Areas.

FIRST, I agree that I shall at all times be and be considered an unpaid volunteer. At no time shall I be, be considered or represent myself as an employee, agent, representative or contractor of RRF and/or Organization, in any capacity. I further agree I agree to comply with and follow all rules, directions and instructions given to me by RRF and/or Organization and its representatives at all times.

SECOND, I specifically acknowledge that my participation as a volunteer and my presence in Restricted Areas and at the Event will expose me to substantial risks of property damage, physical injury, and death, and that I have been fully and adequately warned with respect to all such risks.

THIRD, being fully aware that my participation as a volunteer, other visitor activities, or otherwise being present in or around Restricted Areas and/or at the Event, will result in my exposure to substantial and serious hazards and risks, I voluntarily and irrevocably assume and accept full responsibility for all such hazards and risks and hereby unconditionally and forever discharge, waive, release, indemnify and agree to defend Rider Relief Fund and/or Organization, and their respective parents, subsidiaries, affiliates, officers, directors, shareholders, members, employees, representatives, escorts, contractors, volunteers and agents, together with all Event venue owners and operators, producers, sponsors, advertisers, promoters, production entities, as well as all Event contestants, bull fighters, judges, officials, stock contractors, and all other parties involved in the production, organization, security, conduct, sponsoring and performance of the Event, and/or other volunteer and/or visitor activities (and each of their respective parents, affiliates, directors, officers, employees and agents) (collectively, the “Released Parties”), from and against any and all claims, demands, suits, liabilities, and responsibilities for any and all property damage, personal injury, death, damage or loss of any kind arising out of or in any way related to the Event, my participation as a volunteer and/or other visitor activities, my presence at the Event or in any Restricted Area, or otherwise, whether or not such claims, demands, suits, liabilities and other responsibilities are occasioned by the acts, omissions, negligence or gross negligence of any Released Parties.

FOURTH, I shall not now or at any time in the future, directly or indirectly, threaten, commence or prosecute any action, suit or other proceeding against any Released Party arising out of, or related to, the claims, demands, liabilities and other responsibilities so discharged, waived and released by me.

FIFTH, I hereby grant, assign and transfer to Rider Relief Fund and Organization, and their respective and duly authorized agents, transferees, licensees and assigns, the perpetual and royalty free right to use, display, publish, perform, reproduce, distribute, transmit, alter, create derivatives of, transfer and otherwise publicly and commercially exploit, on a non-exclusive and perpetual basis, my name, image, voice, likeness, persona, and other distinctive personal characteristics and publicity rights, including, without limitation, pictures, photographs, films, images and sounds of me captured or recorded at, in or during a backstage tour, volunteer activities, other visitor activities, or the Event, in any way, medium or material, whether now known or hereafter created, including, but not limited to, use, display, publication, performance, reproduction, distribution, transmission and exploitation in print, television broadcasts, radio, film and video recordings, audio productions, and transmissions over the Internet (collectively, "Appearance"). I hereby waive any rights of inspection or approval of my Appearance or uses to which my Appearance may be put. I also expressly waive any and all moral rights I may have in connection with my Appearance as set forth herein.

SIXTH, I understand that a RRF and/or Organization event credential may be issued pursuant to this Agreement. Credentials are the exclusive property of RRF and/or Organization and as such must be surrendered upon demand by RRF and/or Organization, in RRF's and/or Organization's sole discretion. Any credential lost or stolen must be reported to RRF and/or Organization immediately. Failure to timely report a lost or stolen credential may result in suspension or revocation of credential rights. I understand that any credential issued hereunder solely permits me to enter into Restricted Areas prior to, during or after the Event solely in accordance with the rules, directions, instructions and procedures for access as may be established by RRF and/or Organization from time to time. RRF and/or Organization may require that I carry certain identification, be accompanied by certain individuals, depart such Restricted Areas, take certain actions, or refrain from taking certain actions, and I agree to fully abide by RRF's and/or Organization's directives and instructions in that regard. I understand and agree that any credential issued to me hereunder is personal to me, that I may not sell, assign, lend, transfer or give it to any other person or entity, that any attempt to sell, assign, transfer, lend, or permit any other person or entity to use it shall result in a fine imposed by RRF and/or Organization of not less than Five Hundred Dollars (\$500) and suspension or revocation of the credential and/or credential rights. In addition, I hereby INDEMNIFY AND AGREE TO DEFEND RRF and all related parties for any damages or injuries arising in connection with such unauthorized sale, assignment, transfer, lending or use.

SEVENTH, I expressly agree that the foregoing provisions, including specifically the release, waiver, and indemnity provisions, are reasonable, enforceable and intended to be as broad and inclusive as is permitted by applicable law, and that, if any portion thereof is held to be invalid, it is agreed that the balance shall, notwithstanding such invalidity, continue in full legal force and effect.

EIGHTH, I expressly agree that the undertakings and covenants of this Agreement are binding on me as well as upon my spouse, children, heirs, next of kin, legal and personal representatives, successors and assigns.

I HEREBY AFFIRM THAT I AM EIGHTEEN (18) YEARS OF AGE OR OLDER, I HAVE READ, UNDERSTAND AND VOLUNTARILY SIGN THIS AGREEMENT, and further agree that no representations, statements or inducements apart from the foregoing have been made or are relied upon.
